Please call ahead to make arrangements to meet with vendor staff before setting up your booth. You will not be allowed to have additional space unless you pay for an additional space. You must provide your own tents, tables, chairs, etc. **You are responsible for all trash produced by your customers and your stand. There will be a receptacle for disposal of cooking oil. You are required to use this receptacle for oil disposal.** REMINDER – it is usually HOT!!
